# PROGRAM STRUCTURE

Chitkara Law School's B.A. LL.B. program is a 5-Year integrated law course that gives you the critical thinking, communication, and advocacy skills to prepare you for a successful legal career. Our academic curriculum allows you to integrate theory and practice with a variety of clinics, practicum courses, and externship opportunities. In clinics and practicums, you'll engage in all phases of client representation, including litigation planning, interviewing, counselling, legal drafting, negotiating, discovery, and trial and appellate advocacy. There will also be career talks from local firms and relevant organisations throughout the duration of the course to help you make your decision.

The 5-Year B.A. LL.B. course is divided into 10 semesters. Each semester has a specified number of subjects, and the credits for each are awarded accordingly. The course structure comprises subjects relating to various laws, sociology, economics, history, political science, etc. During the first six semesters, various laws and specific disciplines are combined, along with the English language, forming part of the syllabus.

The last four semesters focus on advanced legal topics, giving students the opportunity to specialise in areas of their interest, such as criminal law, corporate law, or international law. This is complemented by internships and seminars, providing real-world exposure and the chance to work closely with legal professionals. You will also be involved in moot court competitions and legal aid programs, which foster a deep understanding of the practical aspects of law.

B.A. LL.B. at Chitkara Law School will prepare you for numerous career paths, both within and outside of traditional legal practice, such as:

**Litigation Lawyer:** Start a career as an advocate, representing clients in court across various fields such as criminal law, civil rights, corporate disputes, and family law.

**Corporate Counsel:** Work as an in-house legal advisor for corporations, handling legal compliance, contracts, and company policies.

**Judiciary:** Pursue a career as a judge by clearing judicial service exams, allowing you to preside over legal proceedings and make rulings.

**Legal Advisor or Consultant:** Provide legal guidance for businesses, NGOs, or government agencies on regulations, compliance, and policy matters.
